We have held 5 public meetings, created a web-site and social media presence to engage with our community.

✓ A Parish Council for Lytham

We alerted residents to FBC plans to cut down our trees. Residents united to save them. We got an expert tree report and sent it to FBC.

Protecting Lytham Green

We're pushing for Trust status to stop commercial development of the Green.

✓ Making the Festival a better experience

The festival is a commercial venture which we estimate grosses well over £10 million from tickets, car parking and alcohol sales.

By calling out rising crowd sizes and raising issues faced by residents, we have secured improvements which benefit the town and the organisers.

We want more of the money it makes to stay in Lytham for the benefit of our community, paid for through FBC charging Live Nation a commercial rate.

We support asking residents their views and acting on them.

✓ Speaking Up on Crime and Safety

We've asked to meet the police. We want a weekend police presence in Lytham. They have refused to meet us. We will continue to raise crime, anti-social behaviour and safety issues. We will keep at it.

✓ Fighting for Fair Planning Rules

It appears small businesses and residential homes face strict rules. Bars/licensed premises get a softer deal. That's not fair — and we're challenging it.

✓ Tackling Pavement Clutter

Too many obstructions make life harder for those with prams, scooters, or wheelchairs. We say: keep our pavements clear & protect our rights of way.

Capping the Number of Bars

We called for a limit on the number of bars and a Cumulative Impact Policy. 63% of residents and 66% of businesses agreed. FBC still said no. We won't give up.

✓ Stronger Licensing Rules

We want fair opening hours, safer streets — and to stop Lytham from becoming another Blackpool.

✓ Lytham Institute Returned to the Community

We are working with local community groups to safeguard the Institutes future, restoring it to a community asset under the control of independent Trustees.
